Overview

The programme is designed to meet the high demand from the industry for highly-skilled professionals with a strong understanding of the legal underpinnings of shipping.

The programme, which follows on from the success of the London-based LLM in International Shipping Law, offers the opportunity to the students to develop academic and professional expertise in a range of specialised topics in shipping. The classes are designed to meet the needs of professionals who would like to specialise in areas of global maritime law and are taught in intensive monthly blocks by academic staff from the Centre for Commercial Law Studies (CCLS) of Queen Mary University of London, at the Hellenic Management Centre (HMC) in Piraeus, Greece.As such, it allows busy professionals to complete a degree that will enhance their knowledge and practice with a comparative and international perspective.

The LLM in International Shipping Law (Piraeus, Greece) programme consists of six taught modules (assessed by exams or written essays), taught in intensive teaching blocks over the two academic semesters. The frequency of the teaching is once or twice per month from September to April.

Programme Structure

You are also required to complete a dissertation.

Entry requirements

The entry requirements will be the same as with the UK LLM degree - i.e. a degree in law, or a degree with a substantial law content, normally of at least upper-second class (2:1) honours. For graduates of a Greek university that would be a Ptychio in Law (4 years) with minimum grade 7.0/10 or 70% from an AEI institution. Applicants with slightly lower grades but 4-5 years professional experience will also be considered.

As the programme is principally directed to working professionals, non-law graduates will also be considered on the basis of professional experience that directly relates to the specialisation of the programme. Members of the Institute of Chartered Shipbrokers with relevant professional experience will also be considered.

Each application will be considered on an individual basis.
